Lincoln Arts Centre Coin Competition Terms & Conditions

## 1. The Promotor

- 1.1. The promoter is: Lincoln Arts Centre of University of Lincoln, Brayford Pool, Lincoln, LN6 7TS
- 1.2. To the extent permitted by applicable law, The Promoter shall not be liable under or in connection with these terms and conditions, the competition or any Prize for any indirect, special or consequential cost, expense, loss or damage suffered by a participant even if such cost, expense, loss or damage was reasonably foreseeable or might reasonably have been contemplated by the participant and the promoter and whether arising from breach of contract, tort, negligence, breach of statutory duty or otherwise.

### 2. <u>The Competition</u>

- 2.1. The Competition is called Lincoln Arts Centre Coin Competition
- 2.2. Under the 2005 Gambling Act the competition is categorised as a game of chance in that it is:
  - 2.2.1.a game that is presented as involving an element of chance but does not include a sport.

### 3. How to Enter

- 3.1. Public can enter the competition by going to a library that is taking part in the competition, solving clues given to them and finding the gold coins in the library, and figuring out the secret word written on them.
- 3.2. Public can only enter the competition once.
- 3.3. Entrants must fill out a form once they have found the coin to formerly claim be entered into the lottery for the chance to win tickets for A Christmas Carol.
- 3.4. The Promoter will not be held liable for any failure of receipt of entries. The Promoter takes no responsibility for any entries which are lost, delayed, illegible, corrupted, damaged, incomplete, or otherwise invalid.

# 4. Terms & Conditions for Libraries

- 4.1. Libraries must note down the name & email address or contact number or borrower number of winners and send them to the promotor via email.
- 4.2. Winners cannot be employees of the Library.

# 5. Eligibility

- 5.1. Only those who have visited the Library, found the coins and deciphered the hidden word are eligible to win
- 5.2. Employees of the Library in which coins are hidden cannot enter, Library employees can visit other Libraries that do not employ them to take part in the competition.
- 5.3. Entrants must give consent to be contacted by Lincoln Arts Centre by either email or phone call if they win to be given their tickets.
- 5.4. Anyone who finds the coins who is under 18 must have a legal guardian with them and must attend the show with a legal guardian also.

#### 6. The Prize

- 6.1. The agreed prize for the competition is 1 free children's ticket and 1 free full price ticket to watch A Christmas Carol at Lincoln Arts Centre.
- 6.2. Winners can choose any performance of A Christmas Carol to attend, subject to availability.
- 6.3. The prize is non-negotiable, non-transferable to different productions at Lincoln Arts Centre, and non-refundable. No cash alternative is available. Where a prize becomes unavailable for any reason, the promoter reserves the right to substitute that prize for a prize of equal or higher value.
